SUBJECT: APPROVAL OF TENDER FOR THE PURCHASE OF
MEDICAL LIBRARY BOOKS FOR THE YEAR 2009 - 10

The Tender for purchasing the Medical Library books required as per MCI Norms for the year 2009 - 10 was called for by the Director, BRIMS, Bidar

vide notification No. BRIMS/Sup/Medical Books/TND/1/2008-09, dated 16.01.2009.

The schedule of events were as follows:

The said Tender Notification was published in the Prajavani Kannada News Paper on dated 18.01.2009 (All Editions) and in the Hindu Daily English News Paper (Karnataka Edition Hyderabad) on dated 18.01.2009 and also in the District Tender Bulletin Bidar vide No. B/CR/183/2008-09/10245, dated 29.01.2009 of the DC Bidar.

As per Notification the following Tenderers have submitted the Tender documents duly filled with two covers, one cover containing Technical Documents and another one Price Bid.

As per Schedule of event, the Tender cover containing Technical Documents were opened on 03.02.2009 at 3:30 PM in the Chamber of the Director BRIMS, Bidar in the presence of the Tenderers. On Technical scrutiny of the Tender Documents the following Tenderers were qualified for having submitted required Documents as per checklist.

1. M/s. Ahuja Book Co., Bangalore
2. M/s. B. J. Publications, Bangalore
3. M/s. Jaypee Brothers, Bangalore

The Tender of the following Tenderers were disqualified as they have not submitted the required documents such as PAN, TIN/VAT/Sales Tax, Annual Turnover for three years, List of satisfactory supplies/User Certificate, Self Declaration for not having their firms in the black list and they are not in the field of Medical Books Publisher & Suppliers.



The qualified Tenderers attended Price Bid opening on 04.02.2009 at 11.00 AM in Chamber of the Director BRIMS, Bidar.


On 04.02.2009 at 11:30 AM the Price Bid covers of the qualified Tenderers were opened in the Chamber of the Director, BRIMS Bidar and found that all the qualified Tenderers have quoted the published prices and offered 20% uniform discount. On negotiations, the following qualified Tenderers have agreed to give 3% extra Discount over & above 20% already quoted totaling to 23% Discount


1. M/s. Ahuja Book Co., Bangalore
2. M/s. B. J. Publications, Bangalore
3. M/s. Jaypee Brothers, Bangalore

The proceedings of 27.02.2009 were continued on 20.03.2009. The Additional Secretary and the Director of Medical Education opined that in several cases of such purchases by other Colleges discounts in the range of 25% to 30% are being offered by the suppliers and, hence, it would be advisable to negotiate further with the identified Tenderers for a further discount of at least 2%. Accordingly, the Director has pursued action and informed the Committee that the Tenderers have agreed to offer totally 25% discount. The Committee, hence, resolved to permit the Director to procure the Medical Library books listed out for this tender and as required for the IInd renewal MCI Inspection for the year 2009-10 at an approximate cost of Rs. 20 lakhs (Rupees Twenty Lakhs Only).
